Fixins provides marketing automation services to small businesses, including missed call text back, review request management with AI drafted responses, and weekly social media content scheduling, delivered through a white label software platform and managed personally by Fixins on behalf of each client.

Eligibility

authorize Fixins to connect to that business's phone line, Google Business Profile, and social media accounts.

Pricing and Billing

Current pricing is listed at fixinsgrowth.com/pricing. Fixins offers a founding rate for its first ten clients and a standard rate thereafter, as described at signup. Billing is processed through Stripe and begins at the time of setup. Service is month to month with no long-term contract. You may cancel at any time as described in your service agreement, and cancellation takes effect at the end of the current billing period. Applicable Texas sales tax will be added where required by law.

The specific terms of service for each client are set out in that client's signed service agreement, which governs in the event of any conflict with this general Terms page.
